If the UA Series Air Purifier fails due to defects in manufacturing or materials within 3 years of installation, Daikin North America LLC will ship out at no cost a new UA Series Air Purifier replacement unit. To make a warranty claim, contact Daikin at 1-888-726-8869. Daikin will collect the appropriate information to deliver a replacement UA Series Air Purifier unit. Providing the replacement unit is Daikin's sole liability, and your only remedy, for breach of warranty. Labor or other costs incurred for diagnosis, repairing, removing, installing, shipping, servicing, or handling of either defective or replacement units are not covered. Such costs may be covered by a separate warranty provided by the installer.
