1.5 DELIVERY, STORAGE, AND HANDLING

1.6 WARRANTY

- A. Provide the manufacturer's 2-year limited warranty on electrical components.

1. Provide all components and accessories required for a complete, functional unit.
2. UL or CSA listed.

PART 3 EXECUTION

3.1 INSPECTION

- A. Do not begin installation until substrates have been properly prepared.
- B. If substrate preparation is the responsibility of another installer, notify Architect of unsatisfactory preparation before proceeding.
- C. Verify proper power supply and fuel source are available.

3.2 PREPARATION

- A. Clean surfaces thoroughly prior to installation.
- B. Prepare surfaces using the methods recommended by the manufacturer for achieving the best result for the substrate under the project conditions.

3.3 INSTALLATION

- A. Install in accordance with manufacturer's instructions and requirements of authorities having jurisdiction.
- B. Use manufacturer's guidelines for minimum clearances to combustibles, walls, and finishes.
- C. Anchor all components firmly in position for long life under hard use.
- D. Upon completion of installation, visually inspect all exposed surfaces. Touch up scratches and abrasions with touch up paint recommended by the manufacturer; make imperfections invisible to the unaided eye from a distance of 5 feet (1.5 m).

3.4 PROTECTION

- A. Protect installed products until completion of project.
- B. Touch-up, repair or replace damaged products before Substantial Completion.

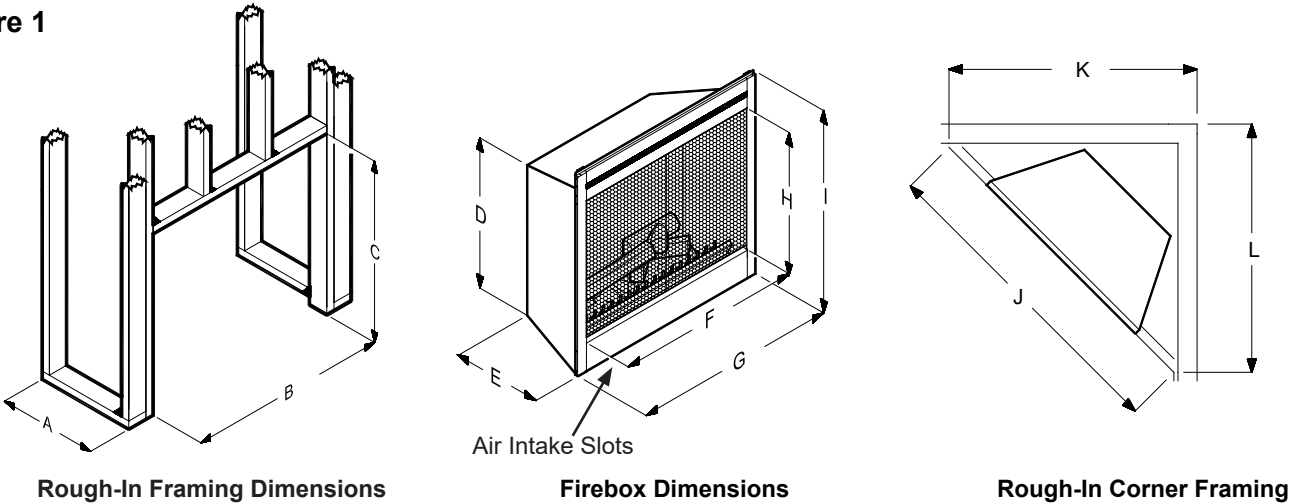

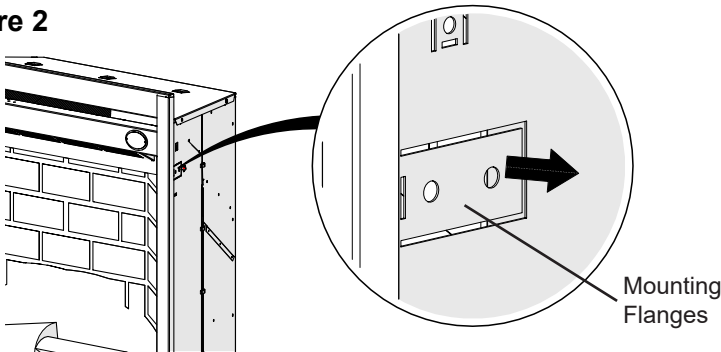
This fireplace is a zero clearance design, with the exception of the top of the unit, where any insulation and vapor barrier should be placed a minimum of 2" (5.1 cm) from the unit. No combustibles can be placed on the top surface of the fireplace.

CAUTION: Ensure installation does not allow fireplace to be in direct contact with building vapor barrier or insulation and meets all local building code.

Four mounting flanges on the sides of the unit are provided to facilitate installation. There are two mounting flanges located on each side of the fireplace insert.

From the inside of the unit, bend tabs outward and mount to the inside of the framing using suitable hardware.
